- A discussion was held regarding starting District Facebook and Twitter accounts. Karie O'Gara has agreed to spend 2-3 hours per week posting. We would need a policy before we move forward. We would also need to update our Photo/Video policy. A helmet cam policy would also be needed. Commissioner Meath also noted that we would need to discuss paying an hourly employee if they are doing things off duty. We could post fire prevention and safety messages as well as motor vehicle and other incidents that could affect traffic. Policies will be presented at the May meeting. A request was made to keep our attorney in the loop.
- There was a large event at the Town Hall on April 9<sup>th</sup> that we heard about by accident. GVA was officially notified. The concern is that traffic was so huge and we were never notified. It would have been impossible to reach some areas of the town with rescue vehicles due to the automobiles. Our attorney recommends that AC Dorgan call Chief Phelan and ask him why we weren't notified.
- A discussion was held regarding the money received from a deployment to Erie County. We
  did not apply for reimbursement. Sam DeRosa will be contacted to see if we can return the
  funds because we had already paid the firefighters and did not incur any district costs due to
  them being off duty or on a previously scheduled vacation. Comm. Andreano will get
  information to the Treasurer so that these funds can be returned.
