- 911 reports: This item will be taken off of the chiefs agendas. If there is a big issue it will be addressed.
- There is a meeting being rescheduled to discuss asset management in Red Alert and barcoding. IT A. Hinds and C. Dewey are working on this project with Chief Meyers.
- Notable calls: There was a house fire in the kitchen at the corner of W. Ridge and Elmgrove Roads. RRFD arrived first. The fire was quickly contained. Group 4 did an excellent job.
- The chief's office does not recommend any changes to the mutual aid plans at this time.
- The chief's office did an annual review of the Fire Police program and is satisfied with the results.

(Commissioner Dallessandro arrived at this point in the meeting).

- There is no need for a meeting between the commissioners and line officers at this time.
- The chief requested that the volunteer lounge room at station 1 be utilized as a volunteer
 officer room. He would like to have a desk or 2 added along with lockable file cabinets. A
 computer (desk top) would be beneficial. They could benefit from having their own space. The
 board was in agreement with the suggestion and it will be presented to the department at the
 next meeting.
- The board was informed that the department would like to participate in the St. Patrick's Day Parade and would need the use of an engine and a van. Members will conduct the parade and return afterward. Lt Bartell is in charge of parades for 2016. If anyone stays for events after the parade they will not be wearing N. Greece clothing. Officers attending the parade will be monitoring. The BOFC's approved the request to participate.

Erie county deployment refund update: There is no record that the district spent any money
for this deployment. Counsel will be sought to see if it is legal to disperse the funds to the two
members that deployed. Union Pres. J. Wiesner will get the E-pro record to see when the
vacation was requested by the member that deployed. Both unions are represented by this
group since one was an officer and one was a firefighter. This will be discussed further at the
next regular meeting.

Comm. DeCarlo asked if the Codes training could be split up to avoid overtime. Due to the
locations and hours required by the Dept. of State it would incur travel cost and may not help
with overtime cost. The training is valuable to improve our ISO credit. We would need to
inspect the schools every 2 years instead of every three years. This is a service for the school
district so they don't have to hire it out. We receive invaluable information from our people
inspecting the school buildings.

- As part of the staff meeting Thursday morning we will be travelling to ECD to test what they
 have in the program with addresses and assignments to see if we can find glitches to be
 corrected. A spreadsheet with different responsibilities is in process. Captains will be
 involved in future procedures. We are on track with the move.
- AC Dorgan would like donate the N. Greece patch plaque to the FLIPS training facility to represent our Fire District and get us a replacement. Sec. Dutton and HR T. Gretzinger will research.
- There was a discussion regarding the current motion in effect for the Squad/Quint 270. The 90 day trial period will be completed before our March 8th commission meeting. The Chief still feels that all responders from station 3 need to be on the same truck. That's why we bought and built it. AC Dorgan suggested that we take the part timer on engine at station 1 to give 3 people on that truck. This might free up a duty officer. Commissioner Dallessandro stated that in the end we need to support those running the operations and address issues on a case by case basis as they come up. D C McManus noted that it is important to recognize the history of our current dilemma. Before 2009 there was no rule imposed where engines couldn't leave unless they had 2 people on the truck. This new rule caused a driver to resign and ultimately another volunteer who couldn't respond and therefore the Quint couldn't be run effectively. After studying the situation it was concluded that we should turn the truck over to career drivers in the interest of safety and timeliness. Not long after the issues surfaced, committees were formed and the situation was studied and came to the same conclusion to run the Quint as we were. We Tried running a squad for a while. We would be negligent as chiefs if we operated the Quint only on Structure A calls and run a squad which is only good for EMS calls. Commissioner Andreano was supportive of letting the chiefs send the trucks that need to be sent on calls.
- Letter from resident Eileen Wood was forwarded to Chiefs. Chief Meyers will formulate a response.
- Examples of needing the Quint 270 during this time period after the squad was sent have occurred regularly.
