- The guests were welcomed and given 10 minutes to present their project to the board. Each one introduced himself:
 - o Bob Bringley is with Marathon Engineering for the proposed Bill Gray's project.
 - o Chris Diamontopoulos is a consultant on the real estate end.
 - o John Gonzalez Bill Grays Admin
 - Rich Mastin VP at Bill Gray's.
- A history of the project was presented. In anticipation of purchasing the 2.6 acres of property at Creek House Drive, they had engineers look at flood plain and wetlands. They discovered that .7 acres is able to be developed at this point. They would place an addition on the south end of the plaza and use the .7 acres for added parking. 70% of the property is not able to be developed due to the creek and the flood plain.
- They are still interested in purchasing the property.
- Atty. Ray DiRaddo asked if the federal wetland and flood plain are both located on our property. Prior to development the owner is responsible to determine if there is wetland on the property.
- Purchaser agreed to do all the work to get the work done before purchasing. In all towns there
 are requirements for seating and parking. Some have green space requirements. Bill Gray's
 would need to increase parking and green space to add on to the existing property. They are
 trying to get the town piece and county piece where the culvert is going under the road. This
 would help meet the green space requirements. This would allow them to pull the whole
 project together with the fewest variances.

- The Fire Police requested to assist at a funeral for a member of the 911 Center to be held at the Greece Methodist Church on Maiden Lane, September 24, 2016 at 11:00 AM. The board approved this request.
- AC Dorgan met with the new director from GVA yesterday. Lake Shore has offered up their station 2 as a 2nd base for them. They are considering moving their daytime ambulance stationed here to that station. It would be there all day every day. This would benefit us in the Dewey Ave. corridor. They are also adding a level of management beginning in January. There will be a Captain on duty covering 2 groups for more supervision.
- The Greece Police Department has requested that we send 5 people to Active shooter training November 14th-16th, and 5 more November 29th-December 1st. There would be no cost to the fire district as the classes will be held at the state academy. AC Dorgan is recommending two members of each group, the training officer and a volunteer go to this training. Those attending must have EMT certification as a prerequisite. This will train them to be the medical person in the warm zone. AC Dorgan was directed to sign them up and send the information to Comm. DeCarlo.
- AC Dorgan would like the board to reconsider hiring 8 full time positions. It is costing us money to cover part time positions and we received 2 resignations this week from part time employees.
