Chairman L. Andreano called the regular meeting to order at 6:00 p.m. and noted the fire exits. The opening of the meeting was followed by the Pledge of Allegiance and a moment of silence to honor our departed members.

- There was a discussion regarding the bids received for Message Center Digital Signs. A spread sheet is appended that shows a compilation of all bidders. It appears that the first bidder is the only one that meets all criteria. The higher you go in millimeters the harder the sign is to read. Since our signs are close to the road we need to consider readability, we wish we could do 12 millimeter, but the cost might make that impossible. We need more power than we currently have at these locations by our signs. We need to remember to consider blacktop work that is already being considered when planning this project. Commissioners Andreano and DeCarlo have both done a write up on these results. We will need to contract for electric and masonry work. Comm. Camiolo would rather we not spend money on signs right now. He would rather see us spend our efforts on our volunteers. Others did not see the connection between the two. The goal is to better our community and get information out to the public. Because of the hill at station 2 we have a short viewing time. The department is interested in our old signs. Station 3 has a dip in front of it that may limit viewing. We may want to consider raising the height at some locations to get better viewing. Monochrome is much less costly, but we are told that the technology will not be supported within the next few vears.
- The Fire Chief proposes that the 4 new lieutenants should have a start date effective January 22, 2017, which will coincide with the beginning of a pay period. He would like to hold the Installation "swearing in" Ceremony in place of the Board of Fire Commissioners Meeting on January 24<sup>th</sup> at 7:00 PM. This ceremony will also include Lt. T. Smith.

- Treasurer Bedford feels that language in SOP 1111 should be updated. The form 1111a also needs to be updated. IT Andy Hinds will be asked to update it for the February 14<sup>th</sup> meeting. He will be asked to send a draft to Comm. Meath.
- The January 24<sup>th</sup> Installation of 5 lieutenants will be held at 7 PM at station 1. The Chief's office will take the lead to get it together. There will be no meeting that night. The new lieutenants and Lt. T. Smith will be sworn in. Class A's will be worn for the ceremony.
- We have had 4 working fires since the last meeting. There was also 1 injury to a mutual aid firefighter which is not serious. A thank you to all firefighters who responded to those fires.
- Fire Chief DeRosa expressed his gratitude to all for the swearing in ceremony. His family was honored and grateful.
- Fire Chief DeRosa will be at the Department Board of Director's meeting on Monday to talk about the appended organizational chart. Next Thursday the chiefs will start planning for 2017.
- The cost of the State Fire Academy was discussed. The board would like the payment to come out of the 2016 budget. It is approximately \$2870 per firefighter.
