The Texas Consortium is not meant to get around the bidding process. You would need to determine that they are what they are. Recommendation from Treas. W. Bedford was made that since we have the specs, we should use the point system and go out to bid. The board has to assure itself that in deciding to buy off of the consortium, they would need a resolution that says there has been investigation done by the chief's office and there is conclusion that going through consortium will save money, especially in man hours saved which is not that easy. We need to understand that it can only be done if we determine that this process is our best option. It also must be done according to the comptroller's steps. The best thing would be to put it out to bid. The past board did not approve the formation of the committee.
