- The Miscellaneous Equipment Bid approval will be discussed in executive session.
- The telephone bill from Frontier moving forward should be costing close to \$600/month
  less due to the removal of charges for T1 lines from the former dispatch area. The bill
  hadn't been switched to the county but is now. We will no longer be responsible for
  these lines.
- The auditors will be coming in Thursday to do the 1<sup>st</sup> quarter audit and the 2016 LOSAP program.

### **Chief DeRosa**

- There have been 1,375 calls year to date with 49% of these calls for EMS services.
- There was a meeting with 9-1-1 management on Thursday to discuss changes to the fire and EMS run cards with May implementation of these changes. We will be

- reducing our EMS responses when the Greece Ambulances are in service and responding right with us and the number of the fire responses have been reduced, especially to automatic alarms and MVA's.
- We are hosting a de-briefing on Wednesday, April 26<sup>th</sup> for an incident involving the death of a 1-yr old child last week. The de-briefing is for North Greece Fire, Greece Ambulance and 9-1-1 personnel.
- The lockers requested at the last meeting arrived this past Friday and are assembled and ready to go at station 1. Thanks to Lt. Gates and crew for assembling these lockers.
- Group 5 Volunteer member update: Lockers have been installed, run cards will be changed within 30 days and we are ready to go with an all-volunteer response to Station 1. They will respond with Rescue 28. Additionally, we have several members signed up for new training on driving and operating Rescue 278. The last phase of this process will be to swap and relocate Engine 277 to station 1.
- Communications Project update: On May 15<sup>th</sup> Radio Technologies will be here for two days to relocate all the radio and MDT equipment in the office behind the former communications area. Both the dispatch console and back up tone generator will be moved, the antennas will be serviced and connected, and all excess wiring will be bundled and placed above the ceiling tiles. They also need to fix the grounds on the electrical system. A quote was submitted for all work. In addition, the career staff has prepped the room for paining, which we will do ourselves in the coming week. Thanks to FF's C. Grierson, M. Hare, and C. Pignato for the preparation.
- The fire departments in the town all met with Motorola regarding portable radios for the trunk system. The Chief is suggesting that we consider a lease to own program. We will receive a 40% discount (\$7800 each). After this we need to continue to buy radios to update our inventory. We will not be able to afford a radio for each officer at these prices. The Chief will make a formal proposal at the meeting on May 9<sup>th</sup>.
- The town and associated fire departments will begin planning next week for the
  anticipated flooding to the northern end, mostly in Lake Shore Fire District. Flooding is
  anticipated during mid-May with more information to come. The lake is currently at
  247.6 feet. The town command center will be opening.
- The Chief will be attending a fire conference in Pennsylvania May 1-3. This is a speaking engagement scheduled prior to his employment at North Greece and will be of no cost to the district.
