Fire Chief S. DeRosa

- Hose testing will take place September 7th at 8 a.m. at the training grounds.
- Two price quotes have been secured for a fit test machine. There will be a demonstration by a local vendor at HQ's on August 28th at 11 a.m. They can provide the machine and maintenance service in our area without the cost of shipping out of state. The cost will be under what was requested. The machine will be permanently housed at HQ's.
- Lt. Adams is in his 2nd week at FLTPS in NYC. Lt. Lombardo begins the end of September.
- Lt. Dean Meyers on light duty and assisting the duty captain.
- Capt. K. Helfer has been appointed the MTO for the district. Lt. Smith reports day to day to him and to chief if the MTO is not here. Training will all be vetted by the chief.
- There are numerous personnel changes coming soon in the department.
- There will be a code F at 6:30 p.m. this Friday. Class A uniforms are to be worn. There will also be an honor guard for Jack Spry's showing.
- HR T. Gretzinger and Sec. Dutton were thanked for getting payroll done in the treasurer's absence.
- A count of volunteers was requested by the board since there will be so many changes made.
- The board agrees that we should schedule quarterly for the backup to do run payroll. There should be front end backup also for the E-Pro system. Capt. Battaglia would be a good option.
