### **Chief's Report:**

- Permission was granted to spend up to \$1800 for hose appliances, spanner wrenches and mounting brackets and hardware for the new Engines 273 & 274 from 3 separate vendors out of this year's budget.
- All radio equipment has been delivered from Motorola and we are awaiting word from them in regard to programming the radios for the current VHF system.
- All hose testing is now complete; we are awaiting the final report from vendor. We do know that there were several failed lengths of Mercedes hose and we are waiting to see the report to find out if any of it is under warranty. The hose testing went well.
- The fit test machine will be delivered later this week with train-the-trainer program coming up in early October. WE are waiting for a Scott adapter for our masks.
- Lt. Lombardo is in week 2 of FLSTP Training in NYC.
- Monroe County Water Authority contract for water main and hydrant maintenance on the training grounds has been reviewed and awaiting endorsement by BOFC. They will maintain and repair it from this point. Commissioner DeCarlo has signed the contract. The band repair for the old one should be good and they said we shouldn't have to touch it.

- Commissioner MacKenzie and Chief DeRosa met with Capt. Knapp. The following were discussed:
  - We will be selling vehicles sooner rather than later. In the next 60 days we will sell the Crown Victoria, the fire safety van, a Tahoe will be going to fire safety, and the old 2C-37 vehicle will be sold. We will keep the current Duty Officer vehicle until the first of the year.
  - o PM inspections were discussed. Some things will be scheduled less often.
  - A monthly summary report will be sent to the Chief and commissioner in charge of vehicles before bills get paid.
  - o The past issue with the Quint Lights may see a reimbursement.
  - o The vehicle budget was discussed
  - o Replacement schedule
  - o The warranty on the Quint is expired.
  - There was a suggestion to make more driveway and less grass at station 3 to prevent the sharp turn which is wearing tires.
  - o The board would like the mileage reported in the monthly vehicle report.

• The Drill Team requested funds to attend a volunteer fireman dinner in Albany on Oct. 4<sup>th</sup>. Rick Douglas is willing to sit down and discuss next year and handling everything differently.

- Our attorney delivered his opinion on department expenditures and their purchase of gift cards.
   This will be forwarded to the other commissioners.
- There was a discussion on the 2018 Budget. A good question to ask is should the taxpayer be paying for certain items.
- For next year we will be looking at grants and costs that are incurred but not currently covered under them such as payroll and overtime.
- The chief was asked his opinion on the future of digital pagers. He feels that knowing what the county is looking at we should keep what we have for the time being. The chief will be looking at our current pagers and who has them for possible reductions.
