# **Chief's Report**

- We have had 275 responses year to date, 58.5% are EMS related.
- Once a date is established by 9-1-1, changes will be made to our current mutual assistance including the reduction from 2 mutual assistance engines down to 1.
   Primary mutual assistance agencies will be Barnard and Ridge Road. Hilton FD will respond mutual assistance with North Greece in the Northwest Region of the District.
- In addition to the response changes, automatic fill-ins have also been revised in that Hilton will send a ladder to Station 1, Lake Shore to send an engine to Station 2 and

Spencerport will send an engine to Station 3. The Captains and the Chief are also working on multiple alarm procedures and fill-ins.

- There will be a Fire Department Organization Drill Wednesday, January 31st at 7 PM.
- Firefighter Shane Bagley is scheduled to start on Monday, February 6th at 07:00 hours. We made a change to the start date to accommodate our payroll system.
- Everything is set for FF John Amo's retirement luncheon on February 1st.
- The Chief will be out of town from Friday morning, January 26th until late Monday night, January 29th. Deputy Chief McManus will be in town and will be covering for him.
- We have been having problems with the mobile app in Red Alert. They have not been able to solve these issues. The rest of Red Alert is fine. IT had a small breakthrough today. We cannot currently rely on iPad's in the trucks at this time.
