HR T. Gretzinger-No Report

Fire Chief S. DeRosa

- We have responded to 771 calls year to date, 53% of those were EMS.
- Effective April 1st, St Paul Blvd is on the automatic fill-in assignment for North Greece Headquarters and Gates FD will be the 2nd alarm fill-in ladder for Station 3.
- DiVal Safety will be coming to North Greece on March 20th to train 4 of our career staff on minor maintenance and repairs to our SCBA's. The premise behind this is to save down time for minor issues with our SCBA's.

- Work on the tower for the County's new Communications System will begin this Monday. The new project timeline is end of April for completion of all work.
- Radio equipment update: We are expecting to have a large multi-town order including the rest of the mobiles for apparatus and utility apparatus, accountability system, and wi-fi capabilities for N. Greece. When a firmware update comes out, the tech will be able to remote in and take care of it. This capability has been mandates by the county unless we want to have radio center do it manually. It should take 90-100 days to receive equipment and 1 month to program piece by piece to install the Wi-Fi capability. The County will purchase and install repeaters. Each agency will have 2 frontline pieces of apparatus with a repeater (we will have ours in the DO vehicle) and there will be a town wide mobile repeater. This program should go live January 30, 2020. Training will be done using our MTO's. We will be able to modify our existing radios using our technician at Skywave. The whole town is working together on this.
- The Chief was selected to participate in a 2-day training program on Critical Decision Making for Complex Coordinated Attacks, sponsored by FEMA and taught by staff from Louisiana State University. The program is 2 full days in April at the PSTF. Monroe County is paying for this training.

- The Mary Cariola dinner was a success. Thanks to Dir. DelVecchio for cooking.
- The suggested bylaw change was defeated at last night's department meeting.
- Two new members were voted in.
- There was discussion regarding giving key fobs to participating social members. Training for workplace violence and sexual harassment is a concern. The board of Fire Commissioners will discuss this and get back to the board of directors. It was asked if we could make the leadership of those groups responsible for the training instead of the district.
