- The Mutual Aid fill-in requests submitted to 9-1-1 are now in effect: Gates and St. Paul are now on 2nd alarm fill-ins to North Greece. BC J. Lissow was thanked for his efforts.
- The recent ISO Study of the North Greece Fire District is complete. We are now an ISO Class II Rated Fire District. As a benchmark, there are only 67 Class II rated fire agencies in the State of New York out of 2,200 fire departments State-wide. Congratulations to all of our members and our leadership. Our strongest areas critiqued were our training program and the fact that we have a volunteer duty crew program. The board and BC J. Lissow (with his committee) were thanked and congratulated.
- The board was thanked for the money to repair and revise the SCBA Maize at the Training Grounds. This project is now completed, and we've heard many positive comments from our participating members about these changes.
- Effective immediately Firefighters Sherman Manchester, Thomas Piazza and Jason Michels are Class 2 firefighters.
- The committee to replace the Fire Police Squad vehicle has started their work which was further discussed in executive session.
