- The secretary attended the NYALGRO conference last week and expressed her thanks for sending her.
- A reminder was given that no business should be conducted by text.
- Notification of the joint meeting with Lake Shore on June 26th will be made (Note: after the
 meeting the Secretary was informed that this meeting has been postponed and will not be held
 June 26th)

IT A. Hinds

- The secretary and IT met with Infopreserve yesterday. They offer a service like Clouddocx which we tried a few years ago. The cost doesn't provide enough benefit to our district and we do not recommend that we use their service.
- A commercial grade booster is being provided by Verizon to assist with cell phone service at station one.
- A new data site is in the process of being worked on. It has grown since its development and needs to be started again from scratch.
- We need a team to redo the district website.
- Now is the time to start 100th anniversary planning for 2022.

Administrator T. Gretzinger

Penflex has notified us that they have a small staff with a current high employee turnover.
They are running 1-2 months behind due to this. Payouts will be later than usual. This has
been communicated to department members by email. Walt communicated that this year we
used the audit for our LOSAP to get numbers to them.

Fire Chief S. DeRosa

- There have been 1,607calls year to date, 56% were EMS.
- Quint-270 was involved in a minor MVA on June 3rd while responding to an EMS Priority 1 call. There was no damage to the Quint. The passenger vehicle sustained minor damage to a mirror and driver side fender. The narrative on the police report states the driver of the passenger vehicle did not yield the right of way to the quint and that the driver failed to get to the right. The driver of the vehicle hit came in twice last week. Today she brought a revised accident report to state that she was unable to move due to other vehicles next to her. She wants us to pay for the damage. She doesn't want to turn the claim in but turned in an estimate to us for \$1500 at Long Pond Autobody. The board discussed their options. The board feels that no liability is to be admitted. The claim should be put it through the insurance and if she ends up owing a deductible the district may consider paying it.
- Engine 272 was partially stuck in the mud following the Greece Gauntlet event on Saturday, June 8th at Arcadia High School. Kerhaert's responded to pull the truck from the mud. The bill has been submitted to the School District for payment. The back story is that the Chief did not want to send the truck. This is the last year a truck will be participating at this event.
- All interviews at North Greece have been completed For Phase 1 of the consolidation study. All data was sent to CGR.
- Work continues at the County radio site at headquarters with a July timeframe for completion. Installation of a new generator is next.

- We are waiting for the end of the legislative session to see what Gov. Cuomo has in mind. On that note, the Chief went to his first legislative session a few weeks ago which was eye opening. There was a press conference where the media stated that the bill to allow billing by volunteer ambulance companies was reported as passed. That was inaccurate. It was enlightening to see the confusion.
 - A voice pager for the 700-800mhz system was shown to the board in preparation for when the
 digital paging system goes away. The county is negotiating a pager/scanner in one unit which
 costs less than our current pagers. We bought 2 to test. The company is currently developing
 a 2-way unit. It has a 24-hour battery and costs approximately \$600. Once the 2-way system
 is developed it is expected to cost an extra \$150-\$200. These can be programmed for any
 type of calls we would like.
