- All North Greece radio equipment has been reprogrammed with just a few very minor issues and we are targeting Monday, April 6th to respond on the trunk radio system for single unit calls only.
- Based on cost and timelines, DiVal Safety will be hydrostatic testing SCBA cylinders beginning next month. Ten cylinders at a time will be going to their shop in Buffalo.
- Chief Officers are looking at alternatives to the digital pagers for all membership in the coming months. The current paging system will not be repaired if it breaks down and with the new radio system, it's time for a technology change. The digital pagers are costing the Fire District approximately \$6,000 annually.
- The OHD fit testing machine is back at the factory for annual calibration with a 2-week turnover time.
- The Chief Officers and Tina Gretzinger have reviewed the current pandemic plan for North Greece and the County's Plan and have several matters that are being worked on.
- Stand-by generator sale: The Village of Hilton has verbally offered us \$6,000. The unit is valued at \$7,500 to \$8,000 and was advertised for several months. The board needs something in writing and will note that it is being sold in as is condition.
