 The law says absentee ballots can be done by resolution currently. We are unsure whether
 the governor is going to do anything to override the current law. Our attorney hasn't heard
 anything on his end about requiring them.
- There was discussion of having shorter voting hours this year.
- The board was notified of a requirement to change to the LGS-01 Records Retention Schedule by January 1, 2021.

Fire Chief S. DeRosa

- We have had 1,788 calls year to date, 46% of those were EMS.
- FF-1 Class has resumed at PSTF, no word yet on fall classes.
- Beginning tonight, Lake Shore and Barnard Fire Departments are beginning a cross training night. North Greece will be participating at one of these cross-training nights beginning in September. More information to come.
- Hose testing for all district apparatus begins this Wednesday and should conclude on Thursday.
- DMV Update: The soonest North Greece can get an appointment with the Monroe County DMV is September 29th to register the Tahoe and surrender the old license plates. We were instructed to continue insurance on the vehicle until the plates are surrendered.

- The 2020 Town Memorial Service is cancelled, North Greece will host the event on October 3, 2021.
- We have had two working house fires in the past 24-hours, both with great stops and no injuries.
- Motorola will be at Station 1 every day next week to begin the loading of software and training
 for the accountability system. This will hopefully be the last step in the radio project. That said,
 North Greece is operating on the trunk system for single unit/non-mutual aid responses with
 no coverage issues. Fire Police will be coming on the system when their radios arrive.
- The request and training outline were sent to the State Fire Administrator yesterday. Once
 formally approved, we will complete the prep work for a September 29th start date. The
 program will be 11 weeks with a mid-December graduation for everyone. We have accepted 2
 from the St. Paul Fire District and 1 from the Batavia City Fire Department into the class. Their
 MTO's, MFI's and in one case the fire chief are state fire instructors and will be assisting with
 teaching at no charge to the district.

Commissioner M. Beaty

- Ply-mo-vent magnetic receptors have been installed with positive feedback from the crews.
 The chief noted that he and Walt have placed it in the budget to put 3 or 4 more in next year.
- The prospective project manager has looked at the parking lot project at station 1. He brought some experts in to look at it and give us recommendations. We have not yet hired a project manager but need to. He says he believes we have drainage issues. He should supply a contract and we will go from there. Once approved we should use an exception with no need for public bidding like hiring an architect.

 - Our attorney needs to clarify if someone is sick with COVID, can we go back to the procedure and give them credit? There is no one like that now. He will research it for the next meeting.
- Commissioner DeCarlo was asked to talk to a Mr. Michael Jones from Arrow Smith Development (Verizon Wireless) regarding the communication received requesting the placement of a mini antenna on the roof of station 1.
