### Administrator T. Gretzinger

- In house physicals have been scheduled for career firefighters at station 2. There is also a Saturday date for volunteer members with 12 slots, the rest of the volunteers will need to get their physical at Occu-Med. We have been assured that safety procedures are in place at their location. All physicals should be complete by mid-December.
- The board discussed employee (this includes volunteers) travel regarding COVID. The board agreed that we should follow the governor's plan. Employees will need to use vacation time,

swaps, or comp time after non-essential travel out of NY State to comply with the governor's rules.

### Fire Chief S. DeRosa

- We have responded to 2,558 calls year to date, 47% of those calls were EMS.
- Unication Radios have been distributed to the fire department members and are in the process
  of being distributed to the career staff. The Chief is working with County Radio Center to get
  the digital pagers turned off by the end of this month.
- A resolution from the Board for the Municipal Agreement with Monroe County for the COVID-19 reimbursement is needed. The final step will be signing by the Chief, Chairman Emerson, and finally the county executive before a check is sent.
