The Chairman called the regular meeting to order at 6:00 p.m. and noted the fire exits. The opening of the meeting was followed by the Pledge of Allegiance and a moment of silence for our departed members. 10 people were in attendance.

Commissioner M. Beaty

- Buildings/Grounds update:
 - The Plymovents were installed today.
 - The snowplow contract was signed and turned in.
 - Phase 1 and 2 of the paving projects at Station 1 (parking lot entrances) are done. Seeding will be done in the spring. Some epoxy is needed between the old concrete and the new pad. They were unable to tie the drainage in to the retention pond, so they tied it into the existing catch basins to Latta Road. Trees and brush were removed that had been blocking sight lines to Latta Road. They will place a tack coat around the edges where the new meets the old to bond it tighter. This company did a great job.

Chief S. DeRosa

- Thanks to Comm. Beaty for a job well done with communication on the paving project. This was a big project.
- An estimate was received from Servpro for disinfecting Station 2 following the Commissioner Elections of \$1,295 including bathrooms and hallways. It is on the schedule for 10 AM December 9th.
- The tentative date for Recruit Firefighter Graduation is Saturday, December 19. Because of COVID restrictions, we will have to swear in the candidates 3-4 at a time. The tentative plan is to start at 9 AM for the first group, 10:30 for the second, Noon for the third and finish the last group at 1:30. This plan is tentative in accordance with the current COVID color for Greece. If we go "Orange" this will be postponed; the recruits will get sworn in individually and have a ceremony once we are out of lockdown.

- COOP and Operations Plans are ready should we revert to orange or red status, per the State guidelines and Executive Orders.
- The County of Monroe did request our bank information for wiring funds. We should be
 receiving the CARES Act reimbursement in the coming weeks. I would ask that these funds be
 put back into the EMS budget line as the second wave of COVID will quickly use up our supply
 of PPE.
- Those retiring in 2021 may be slower than usual due to the slow response from the state in providing their numbers.

- All commissioners were encouraged to check their mailboxes at Headquarters and sign vouchers at least once a week.
