- A discussion was held regarding switching to the county medical standards rather than the ones we wrote ourselves. Dr. Cushman has reviewed them and believes we should take the advice of Dr. Maskielle and start using the county standards.
- A discussion was started regarding our residency policy and whether we are unnecessarily limiting ourselves by using only the N. Greece Fire District for hiring. Civil service would allow us to narrow it down from the county to the town, to the district. This discussion was tabled for further thought.

Commissioner T. Emerson

- The strategic planning committee will be added to T. Emerson's duties. The secretary will get him the most recent draft from 2018.
- There was a discussion regarding LED signs for the firehouses. Comm. Emerson is looking into possible grants.
- The Chief will review SOP 1402A which appears to be a motion to adopt reporting for suspected child abuse.

Commissioner M. Beaty

- The discussion of LED signs continued. He would like to do 3 signs, 2 at station 1, and 1 at station 2. We were referred to Skylight which sells Firewatch signs. They are local. Comm. Beaty is to get other quotes. Station 3 already had the electric run when we did the last concrete/paving project.
- We are in the process of getting quotes on a tractor. New Holland approved us as a rent or lease for one year which would cost around \$3,000 a year for a 55 hp tractor.

• The auditors are close to the end of the audit process. There are 4 or 5 documents to provide, then we can sign off to approve.
