- There was a discussion regarding funding and invites for the 2022 Inspection Dinner (100<sup>th</sup> Anniversary). The attorney informed the board that they should keep the cost under \$75 per person because elected officials may not accept a gift greater than that amount. The department is not under the same constraints that we are as a district regarding funding this event. If the district pays for elected officials to attend as guests, we should demonstrate the value received. It was suggested to also approach the Exempts for funding. The exempts or department could cover that cost without question. Sec. Dutton will contact the committee to secure a venue and come up with a guest list.
- The board is in favor of a 14-day trial with Case Text for online lawbooks. The secretary will start this when she and the Administrator can give it a good trial.

### **Deputy Treasurer 2 K. Preston**

- The annual meeting in May at Turning Stone has almost 500 people registered, 300 for the full
  conference. Restrictions on the Exhibit hall is limited to 200 people at one time. Meals are
  another issue. The program itself isn't very restricted and shouldn't be a problem. Since we
  missed last year, the memorial service will be longer than normal. There are 92 people being
  recognized.
- Coffee with commissioners will continue. All were encouraged to view last Saturdays session which is now on the website regarding Cannabis and marijuana.

### Fire Chief S. DeRosa

- There have been 803 alarms, year to date, 52% of those were EMS, which is down about 10%.
- The grass fire truck is ready to be sold. It has a value of approximately \$4,300 to \$7,300. We are looking for a minimum bid of \$5,000. The v10 motor needs exhaust manifolds. The board approves with moving to sell this vehicle as it was previously made surplus.
- Ladder testing is completed with no major issues found.

- Administrative Order 2021-010 is completed and distributed, thanks to Tina for working through this very confusing matter.
- Problems continue with the CAD System and alerting tones. The fire chiefs from Battalion 2 have a meeting with County Public Safety Officials on April 28th.
- Group 5 (active) firefighters will begin cross training with Barnard and Lake Shore Fire Departments on Wednesday, April 28th. This will be a monthly event and will rotate sites.
- We need to begin securing travel for Lt. Mike Dorgan for FLSTP Training in May. Mike is awaiting final word on the pilot class which is reduced to 2-weeks.
- The fit testing machine is out for annual recalibration and needed repairs.
- Kari is working on ordering annual service award gifts for both the 2020 and 2021 calendar vears.
- Hose project to be discussed with Commissioners Rickman and Beaty.

### **Commissioner M. Beaty**

• New Holland Tractor has approved us for leasing a 55 HP tractor with loader at a cost of \$3,500 for the year. They cover everything including the maintenance. At the end of the year, they pick up and bring a new tractor for lease or negotiate a purchase. We will be able to use it for pallets at the training grounds for 3 seasons and then at station 1 for winter plowing. The unit has an 89" pusher blade for a purchase price of \$1,675 and a pallet fork for a purchase price of \$975. It can move, lift, and flip cars for use in extrication training. The currently owned tractor will move to station 3 for snow removal.
