## Administrator T. Gretzinger-No Report

## Fire Chief S. DeRosa

- There have been 2,196 alarms, year to date, 54% of those were EMS.
- The burn building at the Training Facility is fully repaired and back in service.
- Probationary Firefighter Jacquies Chennell started the Recruit Firefighter Training Academy as of August 23rd.
- The 2021 Service Anniversary & Awards Ceremony is on schedule for Sunday, September 26th, 1 PM at the Blue Barn Cidery. Commissioners should wear class A uniforms if possible.
- The Town wide Memorial Service is scheduled for Sunday, October 3rd at North Greece Station 1 at 1 PM. North Greece is hosting. Gene Preston is leading the planning team.
- There is a town wide Outdoor Open House scheduled for Sunday, October 10th from Noon − 3
   PM at the Greece Athena High School Parking Lot. This is the second year all four fire
   departments have come together to hold an open house in the outdoor setting. Residents can
   drive through or park and stay outdoors.
- For the annual (required) inspection and cleaning of all turnout gear, we are going to use Redline out of the MA area. They will be here at North Greece in early-November and will clean and inspect all the gear on site. What normally takes 2-months to complete will be done in 3-days. They travel to the stations and use a mobile setup for cleaning and inspecting. Pricing is comparable to what we are paying with the current vendor. This should help with receiving a bill to pay before the end of the year also. They are NFPA certificate owners.
- The large ventilation (rooftop) fan at Headquarters is out of service and requires replacing. The cost is in the vicinity of \$6K and requires the use of a crane to remove and reinstall the new unit. They are scheduled to accomplish this later this month and Commissioner Beaty is aware and has approved this emergency expenditure.
- We responded to a 2-alarm fire with engines 278, 274, 270 which resulted in contaminated turnout gear. It was all picked up and taken to Turnout Express. We will send the bill to the Ridge Road Fire District. The Manufacturer of the issue at the Kodak Property will be reimbursing us.
- CGR invoices have been collected by Barnard.

It was not done last year due to the logistics of running out the back doors and curing time. There is a suggested mandatory walk thru on 20<sup>th</sup> Kari to touch base on when it would be printed in the D&C. (post meeting update: The walk thru was changed to the 23<sup>rd</sup> and it will be printed in the September 18<sup>th</sup> Democrat and Chronicle).

## **BUDGET**

- The Budget discussions continued from last meeting.
  - We were surprised by NYS retirement with a Projection/Estimate difference of \$40,000.
     The best guess is that the invoice will be closer to the estimate. There has been a substantial increase over the last 3 years. They plan on dropping 1% on tier 2 next year. Solutions were discussed in forecasting this cost.
  - This week's revisions took out about \$300,000, which took us from a tax rate of 9.8% to 6.3%. There is nothing else to take out. We will do what we can this year to prevent spending next year to repair our buildings. We are in line to maintain our business and that is it. We really need to show the taxpayers what they're getting for their tax payment.
- We are slated to come in below our spending limitation.
- The Chief reported some things he'd really like to do in 2022: We really need to consider purchasing thermal imaging cameras, we need to look at phasing out the current air monitors that we have, air packs, RIC bags. Those are the last other than fire truck replacement. Also 2 AED's, mobile radio, and finishing the training grounds repairs.
- Next agenda: discuss voting for December.
