Administrator T. Gretzinger-*No Report*

Fire Chief S. DeRosa

- There have been 2,507 alarms, year to date, 55% EMS. Emergency Department wait times for EMS agencies is exceeding the norm, meaning, on scene times and increased EMS calls for the fire departments.
- The town memorial service went very well, thanks to the Board for the support.
- The town Outdoor Open House went very well. It was well attended by the town school kids and citizens.
- Thanks to the Board for the assistance with the 2021 Service Award Event at Blue Barn, the event was well attended, and we were able to recognize 2 years' worth of service anniversaries and recognize significant accomplishments of our personnel these past 2 years.
- There was no decision from the Appellate Court for the CHS appeal. The next date for decisions to be rendered is November 12 or 19.
- Most of the ordered fire hose has been delivered and some of it is already in service. We are
 awaiting the word from the engine captains to plan the delivery of the existing hose to the
 factory to be cut down and recoupled. Fire companies have been training on the new layouts
 and pressures.
- This is the 7th week of 12 for the fire recruit class. It is going well.
- Hose testing for 2021 has been completed.
- Our hydraulic tools were serviced last week.

 The town fire chiefs will be meeting with the 911 coordinator to discuss issues. On the table is a dedicated Town of Greece dispatcher. The public safety director is committed to making this right.

Commissioner M. Beaty

- Station 1 paving update: Bayside started milling this morning and completed the milling of the rear parking lot, the front from where the previous project ended, the north parking lot and driveway. Tomorrow they will begin installing fabric and stone. Not sure when they'll start paving.
- Our leased tractor has arrived. Lt. Gates was instructed on its use. He will train a few individuals. The pusher blade arrived and was not the right one for us. Empire is looking into another unit and ballast box for weight.
- We are looking at a possible long-term contract with Bartlett for lawn maintenance where needed.
