# IT/Deputy Treasurer A. Hinds

- New copiers have been ordered for station 1,3. The order states 4 to 6 weeks, but they should come in sooner.
- Message centers update: met with the electric and sign companies to stake out station 2.
  Skylight to install posts next week, then the electric can be run. This sing should be in before Christmas. Station 1 is further out. The staff member that will be handling content on the sign has not been discussed.
- After looking at our cell phone plan, we're going to have to pay for hardware starting next year. Phones available have now been changed, and our bill per person will probably go up to \$50/ month. Which means the stipend would need to be raised. The board was asked to consider scratching phone accounts and give everyone the stipend. Past experience is Verizon is the best provider. Walt recommends setting it up as a stipend in payroll so there is no need for check writing. The SOP must be rewritten to reflect no more district provided phone. Andy Hinds agreed to do this, and it will be placed on the next agenda.

# Administrator T. Gretzinger

We increased the allowable number of firefighters from 55 to 70 at the September meeting.
 There was no budgeting for it as there is not an intent in 2022. This should meet our legal requirement.

### Fire Chief S. DeRosa

- We have responded to 2,810 alarms, year to date, 55% of those were EMS.
- Hospital wait times and surges continue with no relief in sight.
- Information on booster vaccine was sent to all members and employees last week.
- Annual gear inspections and cleaning are currently underway and its anticipated we will be completed by the end of the day tomorrow.
- Fire Police running assignments and tasks once on scene are being modified to improve member safety in lieu of limited manpower.
- Barnard, Lake Shore and North Greece cross training evolutions have been halted until after the new year due to several issues with all involved agencies.
