- There was a discussion regarding updates to SOP 1111 (Cell phones). For some of those

 how much the stipend/reimbursement should be. This discussion will continue at the next
 meeting.
- The board was updated on the election procedure. It will be held in the truck room and done like last year. Masking may be required depending on the COVID-19 situation at the time.
- A. Hinds proposed a project to digitize our microfilm. We currently have 179 rolls to be converted. We currently pay over \$800 per year to store a second set of these films offsite. If we digitize, not only will we be able to retrieve information easily, but we will save this storage fee. It costs \$41,000 to buy the equipment, but we can rent it for \$4500 for one month.
 Between the secretary and IT, we should be able to get this project done in one months' time.
