# K. Preston

- The January MCFDOA installation banquet has been postponed.
- The NYS Recruitment and Retention Task Force is looking at the current volunteer recruitment and retention plans of PA and DE as models for NY to consider.
- AFDSNY Issues of united concern were shared:
  - EMS cost recovery bill
  - Reinstate jury duty exemption for all firefighters
  - o VFBL law changes to keep benefits but allow compensation.
  - Recruitment retention tax force, group to have final report by April. They've asked for an amendment to allow all of 2022 to continue working.
- 49 years ago, Ken was elected as commissioner for the first time.

## Fire Chief S. DeRosa

- There have been 3,318 calls, year to date. Please note the significant change to the number of alarms in the past 28-days. EMS calls represent 54% of the total responses.
- North Greece responded to 76 calls for service in a 38-hour window during this past weekend's windstorm.

This is at a cost not to exceed \$300 each way (Note – the couplings arrived last week, and we'd previously discussed sending Tom to deliver to save approximately 1,000). The boarded added money should Tom not want to make the trip alone.

- <u>EMS Medical Director Services</u> –The contract and pricing for the coming two years has been reviewed. The board needs to approve the expenditure and sign the contract for 2022-2023.
- Replacement Sutphen Engine We have received a contract from Sutphen and a
  payment/savings plan for the engine. The chief recommends the Fire District sign the contract
  and get North Greece into the queue to build the engine with the following payment structure:
  - o December 31, 2021 \$300K
  - o March 31, 2022 \$300K
  - May 2023 \$112,856 (following delivery and acceptance of engine)
  - Net cost of engine: \$712,856.
  - Payment plan saves Fire District \$5,880.
  - \*Note approximately \$30K will need to be budgeted in 2023 for mounting/installation of equipment.
