## Treasurer/IT A. Hinds

• Appreciation was expressed for the fire district's contribution to the memorial service of his father-in-law Sqt. Gary Beikirch this past Saturday.

### Administrator T. Gretzinger

• There was a discussion on holding a public hearing and publishing the notice of public hearing regarding providing partial exemption from fire district taxes for eligible enrolled members of an incorporated volunteer fire company, fire department or incorporated voluntary ambulance service residing within the fire district. If the board moves forward and approves this, active volunteers will get 10% off the assessed value of their property in regards to the fire district tax. The board would need to hold a public hearing and pass a resolution before submitting those eligible to the town assessor's office. This wouldn't go into effect until 2023 if we get it done by March 1<sup>st</sup>. Terminology of enrolled is used which we believe to mean active. This is not retroactive. Volunteers must be active at time of the resolution.

## **Deputy Treasurer 2 Ken Preston**

- An executive order has extended the ability to hold remote meetings through April 1<sup>st</sup>.
- Legislation has passed to ban fire retardant Chemicals in furniture.
- The ambulance pay may get added in the back of the budget. There is a senator willing to back this, we just need an assemblyperson to go along with it.

#### Fire Chief S. DeRosa

- We have responded to 105 calls, year to date. Please note the significant change to the number of alarms in the past 28-days. EMS calls represent 58% of the total responses.
- North Greece finished 2021 with 3,448 total responses. A year end summary report is being submitted and will be available for the February meeting.
- Hose testing, ladder testing, pump testing and inspection of all turnout gear, including cleaning, was completed in 2021. All fire stations were also inspected with Commissioner Beaty, and we are working with the Station Captains on the repair and upgrade lists.
- The hose project is now fully completed, all the cut and recoupled hose is now back on the apparatus and in the storage racks.
- Fire Police member Brian Pennington has resigned from the Fire Department and Fire Police member Ed Roberts has gone inactive to participating social status.
- FF Peter Smith's last day is January 28, 2022. An email was sent to all career firefighters soliciting for anyone who wishes to fill Pete's spot in Group 3, Engine 273. Group change information will be provided to the Board at the next meeting.
- Administrative Orders 22 & 23 were issued last week to address the revised isolation and quarantine guidelines adopted by New York State Health. The Board has been fully updated as to the number of employees isolated due to the pandemic.
