Our auditors Sean Hucko and Lawrence Johnston presented the 2021 financial audit reports.
There was a letter stating they found that we had more than the allowed 20% in our
unassigned funds. We corrected this in January of 2022 with 2022.8000.2.01.11. Moving
forward, we plan to make the correction in December for this year.

Fire Chief S. DeRosa

- There have been 644 incidents, year-to-date. 56% of those were EMS incidents.
- The windstorm on Sunday, March 6, caused 47 incidents and significant damage to Station 1, the duty officer vehicle, and several personal vehicles. The training facility also had damage to the glass doors and the gate.
- We are awaiting the final bill from the electrician and Penn Power to submit the final claim information to our insurance carrier from the power outage and surge on February 27. 2022.
- Service from McCarthy/Irondequoit Fire Extinguisher has been stopped and the final bill will be paid this evening. An RFP will soon be out for this service.
- The Greece Fire Council has officially been disbanded and the remaining cash on hand was donated to the Fallen Firefighters Foundation's upcoming conference. This was personal money from members and not taxpayer dollars.
- Over a period of 1-year, parts of English Road will be closed for culvert replacements, beginning in April. Running assignments will be revised later this month to maintain service to those areas in District 3.
- Lake Shore Fire District has started EMS transport services from Monroe Ambulance.
- A written proposal from the committee chosen to replace the thermal imaging cameras, as is planned for the 2022 budget year will be sent to the board. If any of the Board has questions after reviewing the proposal, please contact the chief.

• On March 16th at 0800 hours, revised running assignments will go into effect at ECD. All Greece fire agencies have revised their assignments in accordance with NFPA 1710.

Commissioner W. Bedford

- 2022 miscellaneous tax districts were received today and emailed out.
- 100th anniversary and inspection and service awards update: Commissioner Stolte attended the Board of Directors meeting. They reviewed all cost associated with both the anniversary and awards events, the cost associated with each one, and who would pay for each. Their conclusion was double-checked with Commissioner Bedford. The department will pick up expenses for the fall awards and we will cover allowable expenses for the inspection dinner. The awards recognition will be put together by the chief and president and all invoices will be picked up by the department for that. Will both be under budget and meet legal requirements. Chief asked to move forward with recognition.
- Purchasing a utility trailer was proposed. JPR Trailer sales was consulted and suggested a
 2021 7' x 18' car hauler. This would be under DOT specifications and would be able to be
 pulled by all our vehicles. We can have sides built by MSH allowing us to haul dirt. It has
 removable fenders. There was a discussion on the need for this trailer. There is a need, and
 this should save us delivery fees over time. The board feels that sides should get made right
 away.
