- The board was presented with a preliminary report for a roof project at station 1. Comm.
 Beaty asked our construction manager to investigate specifications and ideas for replacing the roof with a metal roof. This should prevent high wind damage. The original roof that has been repaired multiple times.
- We received the car hauler trailer. It is currently at MSH to get sides on it that are equal to the height of the fenders and are removeable. We will also get a toolbox.
- Training facility condition: There is a crater in front of the doors to the Morton building. The roadway and blacktop were done piecemeal over the years. Our construction manager is willing to meet with us to review this issue. The roadways need to be fixed along with additional areas leading to where they do extrication training. The building itself needs some work including structural and cosmetic. Chief DeRosa spoke to the importance of the project and noted that window and door frames are rotting. Doors at the training ground have been repaired from the windstorm damage. Comm. Bedford will contact the construction manager to start this process.
- Windstorm damage has now exceeded \$10,000.

 A vehicle replacement plan is being started. State contracts should come out at the end of April for 2023. Last year they came out and were closed before we could proceed. We need a plan should this open.
