# **Deputy Treasurer 2 K. Preston**

- Federal mileage reimbursement rate is changing to .625 cents as of July 1<sup>st</sup>.

- We have considered joining the chiefs with the AFDSNY Meeting at Turning Stone, but they

- The State Coordinators invited the Commissioner of Homeland Security to a meeting. It went well. You may see some changes coming in the OFPC lineup.
- MCFDOA cancelled the meeting at Fishers. There was also low attendance at Brockport. Newly elected commissioners don't seem to attend.

### Fire Chief S. DeRosa

- Apparatus update:
  - The DO vehicle is still at Bob Johnson. The check engine light came on before leaving the parking lot. The computer said it was a cam shaft failure. They replaced the sensor, but it didn't correct the problem. We are waiting for the factory.
  - Sutphen: We are in favor of sending the Sutphen apparatus for repair to the manufacturer. Our insurance broker asked us to call the adjustor. They may be able to reconcile the difference in the estimates. The Chief will call tomorrow.
- The Annual Awards Ceremony will be held October 2<sup>nd</sup> at 12:30 PM at Red Fedele's.
- We are part of a July 4th detail on Monday at the town celebration. They had to file a part 18 application. There could be 15,000 people in attendance. All agencies in town are beefing up their staff. Engines 278 and 272 will be there. We have also borrowed the county ATV and Scottsville's ATV which will be staffed with an EMT from Monroe so that we will be able to get through a crowd. There is a unified command post at the Police Department with all the right players. The event starts at 4 PM Monday.

   Parma is still working on it. Greece now has taxable value at 86% of the full value. Parma moved to 81%.
