- The communication equipment approved at the last meeting is on order with no estimated arrival date. Replacement batteries and shoulder mics will be ordered once the estimate arrives from Motorola.
- The replacement 2C-37 vehicle is now in service, thanks to Lt. Jeff Gates and BC Battaglia for their work in getting this vehicle and putting it into service.
- The replacement pickup truck purchased several months ago was picked up today and driven to Albany, NY to have the running boards and snowplow installed. The vehicle will be delivered back to North Greece once completed.

- Pavement sealing and striping have been completed at stations 1 and 2. They recommended
  not sealing station 3 as it is in disrepair, and it would be a waste of money. An area 150x28 of
  pavement needs replacing.
