- We have responded to 2,846 calls year-to-date. 59% of those were EMS calls.
- We responded to one working fire at White Swan Dr. It was a wheelchair fire; the caller used their medical alert to make the call.
- The town-wide Open House has been changed by Barnard. It will be from 9 AM-12 PM with the town-wide memorial service beginning at 1 PM.
- The 9/11 remembrance will be held tomorrow at 9 AM. We have a nice 15–20-minute program planned.
- Station 1 painting has been completed.
- Cyber security training is going well.
- We have not fielded many questions on the bond vote

- The English Rd. property acquisition is going well. Some small issues with the title are being worked out. The title insurance company is willing to insure over those mortgages that hadn't been pulled off. Asbestos still needs to be removed. A report identifying material is forthcoming.
- The current owner didn't cut their lawn, so the town slapped a lean against the property. We will get credit for that at closing.
