Fire Chief K. Battaglia

- We have responded to 3,175 calls year to date. 59% of calls were EMS.
- We responded to an automatic alarm at the Arcadia High School field house fire early this morning. There was smoke upon arrival. This building was saved due to the alarm.
- An Intermunicipal agreement with the Ridge Road fire district for the use of their PIO when
 necessary was signed by the chairman. This protects both parties and gives the PIO the
 ability to speak on our behalf.
- The chief attended the Greece Rotary meeting last week. They posed good questions and were supportive of the fire district.
- The October 6 Open House and memorial service went well.
- Rescue 278 will be at the town of Greece trunk or treat program.
- The memorial dedication will be held Saturday morning October 26th at station 1.
- A MVA took out our North Greece preemption device near Creek House Drive on N. Greece Rd. We have a police report and are talking to our insurance company to see how to handle this.
- The Fire Safety vehicle is getting paint work done this week.
- Station 3 update: We met with engineers today to discuss details like HVAC placement. Bid docs should be prepared by Oct 21 for site work.
- Department news: The board approves of the department using the station 1 parking lot for a Sammy's Sweets fund raiser on October 24.
