- We have responded to 3,418 calls year-to-date with 59% of those being EMS calls.
- Unit based dispatching starts on Monday.
- Station 3 update: The closing date has been delayed waiting for RGE and permits to destroy the white house. This should not affect the bid process. We just can't award any bids until closing. The church next door has been using part of the property for years. The board isn't pursuing a legal battle over the land they've been using.

- The accepted quote for Station 2 bunk room windows did not include prevailing wages. They are now asking for \$700 extra to cover the cost. The other quote also did not include prevailing wage. Comm. Maxwell requested the 2<sup>nd</sup> company to re-quote also, although Comfort has already started building the windows and we will have to go with them.
