- The district held a competitive sale of the \$13.8 million BAN on February 17, 2026. The BAN was awarded to Jefferies LLC at a 3.50% coupon with a premium of \$138,281, producing a net interest cost of 2.4951%. Closing is scheduled for March 5, 2026, at which time proceeds will be received and the existing BAN and interest will be paid off.
- Treasurer Hinds acknowledged Andrea O'Sullivan of Canandaigua National Bank for her exceptional responsiveness in coordinating the late 4:00 p.m. Friday deposit of the Town of Greece levy check prior to the President's Day holiday weekend, waiving the standard hold, and opening a 7-day CD immediately. Her efforts enabled the District to earn approximately \$6,250 in interest that would have otherwise been missed.
