- The chassis for Q-270 is moving down the line. They have only had a few questions so far. The inspection will be later this month.
- Planning for Reserve 278 remodel is underway.

- The August 13 Greece Fire Commissioner roundtable has been moved to September.
- We will be looking into grants for air pack replacements at the first of the year.

Commissioner W. Rickman

- They are getting ready to paint the station 3 bay doors at 1860 English. Landscaping is wrapping up. We may move on September 3. The apron concrete did not pass its 45-day test. That remedy could push off that date.
- We are planning on having a ribbon cutting ceremony.
